The Grand Jurors of the County of Jackson, State of Missouri, charges that the defendant, in violation of Section 565.020, RSMo, committed the **class A felony of Murder in the First Degree** punishable upon conviction under Section 565.020, RSMo, in that on or about March 16th, 2009, in the County of Jackson, State of Missouri, the defendant after deliberation, knowingly caused the death of Andre Jones by shooting him.

**Count II. ARMED CRIMINAL ACTION (3101099.0)**

The Grand Jurors of the County of Jackson, State of Missouri, charges that the defendant, in violation of Section 571.015, RSMo, committed the **felony of Armed Criminal Action**, punishable upon conviction under Section 571.015.1, RSMo, in that on or about March 16th, 2009, in the county of Jackson, State of Missouri, the defendant committed the felony of Murder in the First Degree charged in Count I, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Murder in the First Degree by, with and through, the knowing use, assistance and aid of a deadly weapon.

**Count III. MURDER 1ST DEGREE (1002103.0)**

The Grand Jurors of the County of Jackson, State of Missouri, charges that the defendant, in violation of Section 565.020, RSMo, committed the **class A felony of Murder in the First Degree** punishable upon conviction under Section 565.020, RSMo, in that on or about March 16th, 2009, in the

County of Jackson, State of Missouri, the defendant after deliberation, knowingly caused the death of Precious Triplett by shooting her.

**Count IV. ARMED CRIMINAL ACTION (3101099.0)**

The Grand Jurors of the County of Jackson, State of Missouri, charges that the defendant, in violation of Section 571.015, RSMo, committed the **felony of Armed Criminal Action**, punishable upon conviction under Section 571.015.1, RSMo, in that on or about March 16th, 2009, in the county of Jackson, State of Missouri, the defendant committed the felony of Murder in the First Degree charged in Count III, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Murder in the First Degree by, with and through, the knowing use, assistance and aid of a deadly weapon.

**Count V. MURDER 1ST DEGREE (1002103.0)**

The Grand Jurors of the County of Jackson, State of Missouri, charges that the defendant, in violation of Section 565.020, RSMo, committed the **class A felony of Murder in the First Degree** punishable upon conviction under Section 565.020, RSMo, in that on or about March 16th, 2009, in the County of Jackson, State of Missouri, the defendant after deliberation, knowingly caused the death of Amir Clemons by shooting him.

**Count VI. ARMED CRIMINAL ACTION (3101099.0)**

The Grand Jurors of the County of Jackson, State of Missouri, charges that the defendant, in violation of Section 571.015, RSMo, committed the **felony of Armed Criminal Action**, punishable upon conviction under Section 571.015.1, RSMo, in that on or about March 16th, 2009, in the county of Jackson, State of Missouri, the defendant committed the felony of Murder in the First Degree charged in Count V, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Murder in the First Degree by, with and through, the knowing use, assistance and aid of a deadly weapon.

**Count VII. MURDER 1ST DEGREE (1002103.0)**

The Grand Jurors of the County of Jackson, State of Missouri, charges that the defendant, in violation of Section 565.020, RSMo, committed the **class A felony of Murder in the First Degree** punishable upon conviction under Section 565.020, RSMo, in that on or about March 16th, 2009, in the County of Jackson, State of Missouri, the defendant after deliberation, knowingly caused the death of Gerard Clemons Jr. by stabbing him.

**Count VIII. ARMED CRIMINAL ACTION (3101099.0)**

The Grand Jurors of the County of Jackson, State of Missouri, charges that the defendant, in violation of Section 571.015, RSMo, committed the **felony of Armed Criminal Action**, punishable upon conviction under Section 571.015.1, RSMo, in that on or about March 16th, 2009, in the county of Jackson, State of Missouri, the defendant committed the felony of Murder in the First Degree charged in Count VII, all allegations of which are incorporated herein by reference, and the defendant committed the

foregoing felony of Murder in the First Degree by, with and through, the knowing use, assistance and aid of a dangerous instrument.

**Count IX. BURGLARY IN THE FIRST DEGREE (1401002.0)**

The Grand Jurors of the County of Jackson, State of Missouri, charges that the defendant, in violation of Section 569.160, RSMo, committed the **class B felony of Burglary in the First Degree**, punishable upon conviction under Section 558.011, RSMo, in that on or about March 16th, 2009, in the County of Jackson, State of Missouri, the defendant knowingly entered unlawfully in an inhabitable structure, located at 9811 E. 61st St. Apt 8 and possessed by Precious Triplett, for the purpose of committing an assault therein, and while in such inhabitable structure there was present in such inhabitable structure Precious Triplett, a person who was not a participant in the crime.

**Count X. ARMED CRIMINAL ACTION (3101099.0)**


