**Basis of Decision:** Based on the information gathered during an investigation, it has been determined by clear and convincing evidence, Jason Jones, did Physically Abuse [REDACTED] Jones and that abuse meets the Kansas Statutory definition of Physical Abuse of a child. Further, It has been found that Jason Jones has Emotionally Abused [REDACTED] Jones, [REDACTED] Jones and [REDACTED] Tayrein and that abuse meets the Kansas Statutory definition of Emotional Abuse of a child. SRS has determined that Jason Jones is a danger to children and should not be allowed to work in, reside in or regularly volunteer for a child care facility licensed by the Kansas Department of Health and Environment. Therefore, Jason Jones, is being placed on the Kansas Child Abuse and Neglect Registry.
